

Checklist

YEAR-END PAYROLL

BEFORE LAST PAYROLL IN DECEMBER

- □ Verify employee and contractor information
- □ Review employee wages for accuracy and completeness
- □ Verify earnings and deductions
- □ Review third party sick pay (if applicable)
- □ Process final payroll adjustments
- □ Report fringe benefits
- □ Report healthcare coverage (if required)
- Consider if payroll processing submission timeline requires adjustment for Christmas and New Year's Day holidays

BEFORE DECEMBER 31ST

- □ Verify company information, including tax IDs and email address
- Verify W-2 delivery address
- Gather data to meet 2020 ACA reporting deadlines (if applicable)
- □ Process bonus payrolls
- Run last payroll for the year
- □ Order forms and envelopes as needed for W-2/1099 processing

BEFORE YOUR FIRST PAYROLL IN JANUARY

- □ Adjust PTO accrual balances for year-end as needed per your company policy
- □ Update employee information, benefits, pay rates, and/or deductions effective January 1
- □ Obtain new W-4 form, if necessary
- □ Review ACA (if applicable)
- □ Review 2021 state minimum wage changes
- □ Review 2021 state unemployment insurance changes

JANUARY

- □ Receive delivery of year-end forms and W-2 and 1099s and review for accuracy if prepared by an outside provider, or
- □ Prepare payroll tax forms and 1099s in house
- □ Make sure your W-3 matches your four quarters of 941s or annual 944

BEFORE JANUARY 31

- □ File 1099's with the Social Security Administration
- □ File W-2's with the Social Security Administration
- □ Distribute W-2's and 1099's to employees and contractors
- □ File form 940
- □ File form 941 or 944
- □ File state withholding returns and state W-2s as required by each state you have employees
- □ File quarterly state unemployment returns as required state you have employees

Note: If a deadline falls on a weekend, the returns or forms are due the next business day.
